FIRST SUPPLEMENTAL ORDER ON SIXTH INTERIM ORDER

Following the issuance of Decision No. 50528 on September 14, 1954 under the above-entitled application, it was discovered that a special condition was inadvertently deleted from Appendix A, Schedule No. 1, General Metered Service. This special condition is:

All meter readings for The Atchison, Topeka and Santa Fe Railway Company will be combined for the purpose of computing monthly bills at the Quantity Rates, and there will be a monthly minimum charge in the amount of the sum of the minimum charges for all meters serving The Atchison, Topeka and Santa Fe Railway Company.

Testimony at the hearing revealed the intent of the applicant to cancel the existing Schedule No. 4 of the filed tariffs, special rate for water service to The Atchison, Topeka and Santa Fe Railway Company, and to apply the general metered service schedule to The Atchison, Topeka and Santa Fe Railway Company with the aforementioned special condition.

Good cause appearing, therefore,

IT IS HEREBY ORDERED that Schedule No. 1 of Appendix A attached to the order in Decision No. 50528, issued September 14, 1954, be and it is modified to read as Appendix A attached hereto.

IT IS HEREBY FURTHER ORDERED that in all other respects said Decision No. 50528 shall remain in full force and effect.

The effective date of this order shall be the same as the effective date of said Decision No. 50528.

The Minimum Charge will entitle the consumer to the quantity of water which that minimum charge will purchase at the Quantity Rates.

SPECIAL CONDITION

All meter readings for The Atchison, Topeka and Santa Fe Railway Company will be combined for the purpose of computing monthly bills at the Quantity Rates, and there will be a monthly minimum charge in the amount of the sum of the Minimum Charges for all meters serving The Atchison, Topeka and Santa Fe Railway Company.
