Southern California Water Company, by the above-entitled application filed March 27, 1953, as amended November 19, 1953, April 9, 1954 and May 24, 1954, seeks authority to increase rates for water service in 12 of its 25 districts in Los Angeles, Orange, and San Bernardino Counties by approximately \$327,000, based on $\frac{1}{1953}$ operations.

This Opinion and Order relate to the matter of applicant's request to increase rates in its Cypress-Los Alamitos-Stanton District by about \$24,000, based on 1954 estimated operations. There were no protests to the granting of this portion of the application.

1/ Applicant's request for authority to increase rates in its Highland District, San Bernardino County, was withdrawn August 26, 1954. Such withdrawal reduced its overall requested increase by \$7,760 to approximately \$319,000, based on 1953 operations.

An adjourned public hearing in this matter was held before $\frac{2}{2}$ Examiner Stewart C. Warner on August 26, 1954 at Huntington Beach. The Cypress-Les Alamitos-Stanton District matter has been submitted and is ready for decision.

General Information Re Cypress-Los Alamitos-Stanton District

The Cypress-Los Alamitos-Stanton District comprises three separate service areas with a combined total of approximately 3 square miles, located in unincorporated territory, Orange County, about 4 miles west of Anaheim, just east of the Los Angeles County line, south of the Santa Ana Freeway, and north of Huntington Beach.

The record shows that the Cypress-Los Alamitos-Stanton District is a potentially fast-growing area with large subdivisions being developed in its vicinity.

As of December 31, 1953 applicant was furnishing water service in its Cypress-Los Alamitos-Stanton District to the number of consumers shown on the following tabulation, segregated according to type of rate schedule.

2/ Original and adjourned hearings on applicant's overall results of operations and its request to increase rates in its Gardena-Lawndale-Normandie-and Lennox Districts were held on January 13 and 14 and March 17 and 18, 1954. Adjourned hearings on applicant's requests to increase water rates in its South San Gabriel (Wilmar), Artesia-South Artesia, Florence-Graham, and Norwalk Districts were held on April 21 and 22 and May 26 and 27, 1954; in its Barstow District on August 3 and 4, 1954; in its Bloomington District on August 5, 1954; in its Bell Gardens (Clara Street) District on April 22 and August 24 and 25, 1954; and in its Huntington Beach District on August 25, 1954.

3/ Other decisions having been issued with respect to other districts involved in the instant application, and the entire matter of the application having been submitted, this is the final decision in the matter. A. 34191 Amd AF

In the instant application applicant requests authority to file a uniform schedule of rates applicable to all consumers in its Cypress-Los Alamitos-Stanton District, and it estimated that by the end of 1954 the total number of consumers would increase to 1,530. Seventeen fire hydrants are connected to the system in this district, and applicant requests authority to establish a rate for fire hydrant service, such rate to be applicable to each water consumer. It is proposed to install 88 new fire hydrants at locations shown on the maps Exhibits Nos. 77, 78, and 79, and a new fire hydrant would be installed upon the addition of every 15 new consumers.

The source of water supply of the Cypress-Los Alamitos-Stanton District comprises 6 wells, each of which is equipped with a deep well turbine pump. Two of the pumping plants discharge into a 50,000-gallon elevated steel tank, and two of the pumping plants discharge directly into the distribution mains through a pressure sand trap and pressure tanks. Applicant drilled a new well for its Los Alamitos system in 1954. Of the gross additions to fixed capital budgeted for the Cypress-Los Alamitos-Stanton District for the year 1954, approximately \$50,000 had been expended as of the end of August, 1954. Applicant's president testified that approximately \$45,000 would be expended annually for gross additions to fixed capital in this district in the future. The amount budgeted for 1954 did not include the estimated cost of the proposed fire hydrant installation of \$17,952.

Rates

The general metered service rate schedule now in effect for the Los Alamitos area was filed with the Commission on November 28, 1921, and the schedules for the Cypress and Stanton areas were filed on January 12, 1931. On September 4, 1935 a temporary optional rate schedule "B" applicable to each district, was also filed with the

Commission, and it has continued in effect in each district since that time. Applicant new proposes a single new schedule of rates for general metered service applicable to all three areas of the district. The following tabulation is a summary and comparison of the present general metered service, optional, and proposed general metered service rates for the three areas.

a. In the optional rate schedule, the charges are computed on blocks of 1,000 cu. ft. or fraction thereof.

At the present regular rate the charge for a monthly consumption in the Los Alamitos area of 1,500 cubic feet is \$3.15; in the Cypress and Stanton areas \$3.50; and under the optional rate \$2.75. The uniform charge for such consumption applicable to all

three areas at the proposed rate would be \$4.34. Applicant has no filed tariff for private fire hydrant service or private fire sprinkler system service, and no tariff has been filed for service rendered to applicant's employees at rates or charges differing from its regularly filed tariff schedules.

District Earnings

The following tabulation is a comparison of earnings information for the Cypress-Los Alamitos-Stanton District as contained in Exhibits Nos. 73 and 73-A, submitted by applicant, and Exhibit 83, submitted by the Commission staff.

There are no significant differences between the estimated revenues, expenses, net revenues, rate base, or rate of return for the estimated year 1954 at the proposed rates, as submitted by applicant and the Commission staff. The staff estimate, which includes the revenue, expenses, and capital related to the proposed installation of fire hydrants will be adopted for the purposes of this proceeding.

Proposed Fire Hydrant Service Rate

In its Third Amendment to the application, filed May 24, 1954, applicant requested authority to file a schedule of rates

for fire hydrant service applicable to all consumers in the Cypress-Los Alamitos-Stanton District for fire hydrant service afforded by . the fire hydrants which are located within the district. The proposed monthly charge would be 15 cents per consumer in the district, in addition to said consumer's regular water bill. Fire hydrants would be installed, owned, and maintained by applicant. Proposed special conditions of the rate provide that no additional mains would be installed for the installation of a fire hydrant; hydrants would be installed on the basis of one hydrant for each 15 additional permanent consumers; and hydrants would be installed only at the request of local fire protection authorities and at the location specified by them. Exhibits Nos. 74, 75, and 76 are letters from the Stanton Chamber of Commerce, Cypress Chamber of Commerce, and Los Alamitos Chamber of Commerce, Inc., respectively, requesting the installation of fire hydrants and approving the 15 cents per consumer monthly charge.

Conclusion

From a review of the record it is evident that applicant is experiencing and will continue to experience a less than reasonable rate of return in its Cypress-Los Alamitos-Stanton District, and that it is entitled to rate relief. However, the rate of return of 6.41 per cent for the estimated year 1954, which would be produced by the increase in gross revenues of \$24,000 proposed in the application, is considered excessive. The order which follows will authorize the filing of a new schedule of rates which will produce additional gross revenues of \$22,500, or total gross revenues of approximately \$69,700. After taking into account total operating expenses, including taxes and depreciation of \$50,200, net revenues of \$19,500 will result. Such net revenues, when related to an estimated weighted average depreciated rate base of \$307,400, will

produce a rate of return of 6.3 per cent. After taking into account annual decline in rate of return attributable to the growth factor in the Cypress-Los Alamitos-Stanton District, it is estimated that applicant's rate of return at the proposed rates will approximate 6 per cent, and we find such estimated rate of return and the components thereof to be fair and reasonable. The filing of new schedules of rates for fire hydrant service, fire sprinkler service, and employees' service will also be ordered.

Total Utility Earnings

The rate of return for the company's entire utility operations after reflecting the rate increases authorized by this decision and previous interim decisions is computed to be 6.18 per cent for the immediate future. After considering annual decline in the rate of return attributable to growth and other factors, it is our conclusion that the applicant's total utility earnings will approximate 6 per cent. We find such rate of return to be fair and reasonable. A summary of the estimated results of total utility operations for the year 1954 under authorized rates is set forth below.

increase in rates in the Cypress-Los Alamitos-Stanton District having been submitted and now being ready for decision,

IT IS HEREBY FOUND AS A FACT that the increases in rates and charges authorized herein are justified and that present rates in so far as they differ from those herein prescribed are unjust and unreasonable; therefore,

IT IS HEREBY ORDERED that:

- (1) a. Applicant be, and it is, authorized to file in quadruplicate with this Commission, after the effective date of this order, in conformity with the Commission's General Order No. 96, the schedules of rates applicable to the Cypress-Los Alamitos-Stanton District shown in Appendix A attached hereto, and on not less than five days' notice to the Commission and to the public to make such rates effective for service rendered on and after October 22, 1954.
 - b. Within thirty days after the effective date of this order, applicant shall file with this Commission four copies of up-to-date tariff service area maps in conformity with the provisions of the Commission's General Order No. 96.
 - c. Within forty days after the effective date of this order, applicant shall file four copies of comprehensive maps drawn to indicated scales not smaller than 200 feet to the inch for each of the systems in this district, delineating by appropriate markings the various tracts of land and territory served; the principal water production, storage and distribution facilities; and the location of various properties of applicant.

Applicant shall review annually the accruals (2)to depreciation reserve which shall be to depreciation reserve which shall be determined for each primary plant account by dividing the original cost of plant less estimated future net salvage less depreciation reserve by the estimated remaining life of the surviving plant of the account; and the results of the reviews shall be submitted annually to the Commission.
