## <u>O P I N I O N</u>

Applicant Sacramento City Lines, presently rendering a passenger stage service within the City of Sacramento and its immediate vicinity, requests authority to extend service between the Tahoe Park Area and the newly constructed Peter Lassen Junior High School in the City of Sacramento.

The proposed extension is sought for the purpose of transporting school children between the Tahoe Park Area and the new school. Service would be provided each morning and afternoon on school days only. The proposed fare will be the same as that set forth in applicant's tariff which is presently on file with the Commission. A letter endorsing the application was received by the Commission from the Deputy Superintendent of the Sacramento City Unified School District.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought.

## ORDER

Application having been filed, the Commission being informed in the premises and it having been found that public and an application.

convenience and necessity so require,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity is hereby granted to Secramento City Lines authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, for the transportation of school children between the Tahoe Park Area and the Peter Lassen Junior High School in the City of Sacramento.

(2) That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following regulations:

- (a) Applicant shall file a written acceptance of the certificate herein granted within 30 days after the effective date hereof.
- (b) Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public applicant shall file in triplicate and concurrently make effective, appropriate tariffs and timetables.
- (c) Subject to the authority of the Commission to change or modify it at any time by further order, applicant shall conduct the service herein authorized over and along the following route:

Commencing at the intersection of 59th Street and Broadway in the City of Sacramento, thence along Broadway, 63rd Street, 9th Avenue, 64th Street, 14th Avenue, 55th Street, 21st Avenue and 58th Street to the Peter Lassen Junior High School at 25th Avenue.

The effective date of this order shall be twenty days after the date hereof.
