SUPPLEMENTAL OPINION AND ORDER

By Decision No. 50682 of October 19, 1954, applicants were authorized to establish and publish nonintermediate rates for the transportation of lumber and forest products from specified points in northern California to specified points in southern California. It has been brought to the Commission's attention that, in Appendix "A" of the decision, "posts, sawn or split" was inadvertently omitted and a reference note was incorrectly shown. The necessary revisions will be made. A public hearing is not necessary.

The order herein will be made effective immediately since Decision No. 50682 became effective on November 8, 1954.





Therefore, good cause appearing,

APPENDIX "A-1" TO DECISION NO. 50682  
AS AMENDED BY DECISION NO. ~~50508~~

"Forest Products" Described:

Forest Products of Alder, Almon, Apitong, Birch, Cedar, Cottonwood, Cypress, Duali, Fir, Gum, Hemlock, Juniper, Larch, Maple, Pine, Poplar, Red Lauan, Redwood, Spruce, Tamarack, Tanguile, White Lauan or Yew, whether or not creosoted or otherwise treated with chemical preservatives, viz.:

Lath (see Note 2),

Lumber, viz.:

The products of saw and planing mill plants, not further advanced in manufacture than by sawing, resawing and bypassing lengthwise through a standard planing machine, crosscut to length and ends matched.

Pickets, sawn or split,

Posts, sawn or split (see Note 4),

Shakes, sawn or split (see Note 1),

Shingles (see Note 3),

Stakes, sawn or split,

Ties

- Note 1. - 3,000 shakes will be considered the equivalent of 1,000 board feet lumber.
- Note 2. - 5,000 pieces of lath (1½ inches by 4 feet) will be considered the equivalent of 1,000 board feet of lumber.
- Note 3. - 50 bundles (200 shingles per bundle) of shingles will be considered the equivalent of 1,000 board feet measure.
- Note 4. - Split posts 4 inches by 5 inches by 7 feet will be considered the equivalent of 10 board feet per piece and Split Posts 3 inches by 4 inches by 6½ feet will be considered the equivalent of 6½ board feet per piece.
