ORDER REVOKING OPERATIVE RIGHTS It appearing by Decision No. 45425, dated March 6, 1951, in Application No. 32123, that Gustave W. Metz was authorized to purchase and operate a passenger stage service, originally authorized by Decision No. 43832 in Application No. 30861, for the transportation of persons between the City of Delano on the one hand, and Olive Grove Camp, Kern County, and Schenley Camp, Tulare County, and intermediate points on the other hand; It further appearing by Decision No. 47895, dated November 3, 1952, in Application No. 33694, that said Gustave W. Metz was authorized to suspend said service for a period of one year, and by Decision No. 49689, dated February 16, 1954, in Application No. 35124, that said suspension was continued for an additional one year period ending November 2, 1954; and It further appearing that no additional suspension has been authorized and that said service has not been and will not be restored; -Therefore, it is found that Gustave W. Metz has failed to resume the above-described common carrier service and that he has, in fact, abandoned said service without the requisite authority. -1-
