O P I N I O N

Applicant D. Moyers, presently operates a passenger stage service between Fresno, Calwa, Del Rey, Sanger, Fresno Air Terminal, Clovis and intermediate points subject to certain restrictions. His authority to operate that service is contained in numerous decisions heretofore issued by the Commission. These decisions have granted or authorized the purchase of operative rights or modified them in various respects. The numerous decisions issued make it difficult, according to applicant, to determine with certainty the precise extent and limitations of his various operative rights. Hence, his request to have all of these operative rights restated and included in one decision.

There is no proposal to change any schedules of service, fares, or rates of charges, or the extent of the present operative rights. After full consideration the Commission finds that public convenience and necessity require that a new certificate be issued to D. Moyers which will redefine all of his present passenger stage operative rights. The new certificate issued herein will supersede all other existing certificates or operative rights presently held by applicant, which will be revoked. A public hearing does not appear to be necessary.

O R D E R

Application therefor having been filed, the Commission being fully informed therein and it having been found that public convenience and necessity require that a new certificate be granted as requested,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity is hereby granted to D. Moyers authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and shipments of express weighing 100 pounds or less, and transported on passenger-carrying vehicles only, between Fresno, Calwa, Del Rey, Sanger, Fresno Air Terminal, Clovis and intermediate points, subject to the following restrictions:

No passengers may be picked up and discharged at points on applicant's routes of operation within the City of Fresno between the intersection of Mariposa and H Streets and the intersection of Fresno and Clinton Avenues.

Service under this certificate shall be conducted as a single consolidated and unified operation.

(2) That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- a. Applicant shall file a written acceptance of the certificate herein granted within a period not to exceed thirty days after the effective date hereof.
- b. Subject to the authority of this Commission to change or modify them by further order, applicant shall conduct operations pursuant to the authority herein granted over and along the following routes:

Fresno - Sanger Route:

Beginning at the intersection of Fulton and Kern Streets, Fresno, thence over Kern Street, H Street, Fresno Street, Fulton Street, Cherry Avenue, California Avenue, Van Ness Avenue, Railroad Avenue, Jensen Avenue to Sanger, California.

Del Rey Route:

From Jensen Avenue over McCall Avenue, American Avenue and Bethel Avenue to Jensen Avenue.

Calwa Route:

From Railroad Avenue over Church Avenue, Chestnut Avenue, Jensen Avenue, Ninth Street (formerly West Avenue), Laurite Avenue and Orange Avenue to Church Avenue.

Also from Church Avenue over Maple Avenue to Jensen Avenue.

Also from Church Avenue over Cedar Avenue to Jensen Avenue.

Fresno - Clovis Route:

Commencing at Mariposa and H Streets thence over H Street, Fresno Street, Shields Avenue, Clovis Avenue to Clovis, California.

Fresno Air Terminal Route:

Leave Shields Avenue over Walker Avenue, Westover Avenue, Clovis Avenue to its junction with Shields Avenue.

New Fresno State College Campus Route:

From Shields Avenue over Cedar Avenue, Shaw Avenue, to Clovis Avenue.


(3) That the certificate of public convenience and necessity granted in paragraph (1) of this order shall supersede all presently existing certificates of public convenience and necessity or other passenger-stage operative rights held by applicant which


are hereby revoked including operative rights created by the following decisions:


