NINTH SUPPLEMENTAL OPINION AND ORDER

Prior orders in this proceeding authorized applicant to deviate from the established minimum rates in connection with transportation service performed for Sears, Roebuck and Company within the Los Angeles area and between that area and other southern California points. The authority is scheduled to expire April 27, 1955. Permission is sought to continue to deviate from the minimum rates for a further one-year period. Applicant proposes to increase the presently authorized hourly, weekly and monthly rates and to add a charge for a new service it will perform.

The supplemental application, as amended, shows that the conditions surrounding the transportation in question which have justified deviation from the minimum rates still obtain. It further shows that the proposed increases in the rates correspond with similar increases in the minimum rates. Applicant asserts that operations under the proposed rates may reasonably be expected to be profitable during the ensuing year.

In the circumstances it appears, and the Commission finds, that the proposed rates are reasonable. This is a matter in which a public hearing is not deemed necessary. The supplemental application,, as amended, will be granted.
