## MINTH SUPPLEMENTAL OPINION AND ORDER

Prior orders in this proceeding authorized applicant to deviate from the established minimum rates in connection with transportation service performed for Sears, Roebuck and Company within the Los Angeles area and between that area and other southern California points. The authority is scheduled to expire April 27, 1955. Permission is sought to continue to deviate from the minimum rates for a further one-year period. Applicant proposes to increase the presently authorized hourly, weekly and monthly rates and to add a charge for a new service it will perform.

The supplemental appiication, as amended, shows that the conditions surrounding the transportation in question which have justified deviation from the minimum rates still obtain. It further shows that the proposed increases in the rates correspond with similar increases in the Einimum rates. Applicant asserts that operations under the proposed rates may reasonably be expected to be profitable during the onsuing year.

In the circumstances it appears, and the Commission finds, that the proposed rates are reasomable. This is a matter in which a public hearing is not deemed necessary. The supplemental application, as amended, will be granted.

Therefore, good cause appearing
IT IS HEREBY ORDERED that Decision No. 48462 of April 7, 1953, as amended, and Appendix "A-I" of Decision No. 49892 of April 6, 1954, be and they are hereby further amended as shown in Appendix " $A-2$ " attached hereto and by this reference made a part hereof.

IT IS HEREBY FURTHER ORDERED that the expiration date of the authority granted by said Decision No. 48462, as further amended herein, be and it is hereby extended to April 27, 1956, unless sooner canceled, changed or extended by order of the Commission.

This order shall become effective twenty days after the date hereof.
