FIRST SUPPLEMENTAL OPINION AND ORDER

Decision No. 50891, dated December 21, 1954, in this proceeding ordered, among other things, that defendant, Pomone Valley Water Company, adjust certain bills for water service furnished to complainant, Richard S. Miller, in accordance with Paragraph B3 of Rule and Regulation No. 17 of said defendant's filed tariff schedules. The order further provided that defendant serve Complainant Miller "and file with this Commission in this \_\_\_\_\_\_ proceeding within thirty days after the effective date hereof a REPORT and PROPOSED BILL ADJUSTMENT setting forth the details of such proposed adjustment and requesting approval thereof by Supplemental Order."

In compliance with the terms of the Commission's order referred to above, Pomona Valley Water Company filed, on Fobruary 10, 1955, a "Petition for Proposed Bill of Adjustment" in which it is stated:

"That during the period of time from January 1, 1954 to January 20, 1955, defendant proposes to adjust the water bills of complainant at the rate of \$9.00 per month, being the flat rate previously charged to complainant by the defendant prior to the installation of the meter to his premises, made on or about November 17, 1953."

Service of said "Petition for Proposed Bill of Adjustment" was certified to have been made by mailing a copy thereof to Complainant Miller on February 8, 1955. A reasonable time has elapsed to have allowed said complainant to notify the Commission should he not have been in agreement with the subject proposed bill adjustment.

The Commission is of the opinion, and so finds, that the adjustment proposed by defendant is reasonable and complies with the applicable requirements of the order in Decision No. 50891, that a public hearing is not necessary, and good cause appearing, therefore,

IT IS HEREBY ORDERED that, on or after the effective date of this order, Pomona Valley Water Company may render Richard S. Miller an adjusted bill in the amount of \$114 for water service furnished to said Richard S. Miller during the period from January 1, 1954, to January 20, 1955, in accordance with its "Petition for Proposed Bill of Adjustment" which petition is made a part of this order by reference.

The effective date of this order shall be twenty days after the date hereof.
