## FIRST SUPPLEMENTAL OPINION AND ORDER

By Decision No. 50335, dated July 27, 1954, in Application No. 35418, A. D. Woolley and R. E. Woolley, partners, were authorized to, and subsequently did, transfer all of their then owned highway common carrier operative rights to Shippers Express Company, a corporation, which said partners had caused to be formed. On the date of filing the application (No. 35418) to transfer those operative rights, A. D. Woolley and R. E. Woolley had pending before the Commission their Application No. 34799 in which they sought certain extensions of the highway common carrier operative rights which they had been authorized by Decision No. 50335 to transfer to Shippers Express Company.

Thereafter the Commission by Decision No. 51286, dated April 5, 1955, in Application No. 34799, granted to A. D. Woolley and R. E. Woolley, as partners, a certificate of public convenience and necessity authorizing them to conduct certain highway common carrier operations substantially as requested.

By petition filed April 16, 1955, in Application No. 34799, it is asserted that the partnership of A. D. Woolley and R. E.Woolley, which no longer exists, had failed and neglected to request that Shippers Express Company, a corporation, be substituted in the place and stead of the partnership as the party applicant in Application No. 34799. The petition requests the Commission to substitute the corporation, Shippers Express Company, in the place of the partnership

of A. D. Woolley and R. E. Woolley as the grantee of the certificate issued by Decision No. 51286.

Therefore, and good cause appearing,

IT IS ORDERED:

(1) That the language appearing in paragraph (2) at mimeographed sheet 27 of Decision No. 51286 reading as follows:

"That a certificate of public convenience and necessity be, and it hereby is granted to A. D. Woolley and R. E. Woolley, partners, doing business as Shippers Express Company, authorizing the establishment and operation of a service as a highway common carrier, ...."

is hereby amended to read:

"That a certificate of public convenience and necessity be, and it hereby is granted to Shippers Express Company, a corporation, authorizing the establishment and operation of a service as a highway common carrier, ...."

(2) That the name

"A. D. Woolley and R. E. Woolley doing business as Shippers Express,"

appearing in paragraph (7) at mimeographed sheet 33 of Decision No. 51286 is hereby deleted therefrom and the following name is hereby substituted therefor:

"Shippers Express Company,".
