N. T. Chastain, doing business as Redding City Lines and presently rendering a passenger stage service between Redding, Oak Grove, Girvan, Benton Tract, and Enterprise communities, requests a certificate of public convenience and necessity redescribing his operations.

The certificate is requested in lieu of those which he presently holds for the purpose of clarification and the extension of service to newly developed residential areas.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought. A public hearing does not appear to be necessary.

Application having been filed and the Commission having been informed in the premises,

IT IS ORDERED:

1. That in the place and stead of the certificates presently held a certificate of public convenience and necessity is hereby granted to N. T. Chastain, authorizing the establishment and operation

of service as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, for the transportation of passengers between Redding, Oak Grove, Girvan, Benton Tract, and Enterprise communities.

2. That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following. regulations:

- Applicant shall file a written acceptance of a. the certificate herein granted within thirty days after the effective date hereof.
- Within sixty days after the effective date hereof and on not less than five days' notice Ъ. to the Commission and to the public, applicant shall file in triplicate and concurrently make effective appropriate tariffs and timetables.
- Subject to the authority of this Commission to c. change or modify it at any time by further order, applicant shall conduct the service herein authorized over and along the following routes:

Route No. 1, OAK GROVE From Market and Yuba, along Market Street, Placer Street, Court Street, Schley Street, Railroad Avenue, Highway 99, Cedars Road, Brandstteter Lane, South Bonnyview Road, North Bonnyriew Road Bonnyview Road. East Bonnyview Road, Eastside Road, and return on Highway 99, Railroad Avenue, Schley Street, Court Street, Placer Street, and Market Street to Yuba Street.

Route No. 2, BENTON TRACT AND HIGH SCHOOL From Market and Yuba, along Market Street, Del Mar Avenue, Delta Street, Santa Fe Street, Loma Street, Benton Drive, and return on Market Street to Eureka Way, Magnolia Street, Eighth Street, and return along West Street, Eureka Way, and Market Street to Yuba Street.

# Route No. 3, ENTERPRISE

Route No. 5, ENTERRISE From Market and Yuba Streets, along Market Street, Fell Street, Leland Avenue, Parkview Avenue, Henderson Road, Wilshire Drive, Bechelli Lane, Loma Vista Drive, Churn Creek Road, Highway 44, County Roads 46 D and 41 D, and return along Highway 44, Bechelli Lane, Wilshire Drive, Henderson Road, Parkview Avenue, Leland Avenue, Henderson Road, Parkview Avenue, Leland Avenue, Fell Street, and Market Street to Yuba Street.

Route No. 4, MISTLETCE From Market and Yuba Streets, along Market Street, South Street, Athens Avenue, Cypress Street, Highway 44, Old Alturas Highway, County Road 41 D, Highway 44, and return along Enterprise Lane, Bechelli Lane, Highway 44, Cypress Street, Athens Avenue, South Street, and Market Street to Yuba Street.

Route No. 5, AIRPORT From Market and Yuba Streets, along Yuba Street, Oregon Street, Placer Street, Chestnut Street, Gold Street, Fig Avenue, Placer Street to Pleasant and return along Placer Street, Olive Street, North Street, Magnolia Street, Butte Street, Court Street, and Yuba Street to Market.
