## $\underline{O P I N I O N}$

By Decision No. 49874, in Application No. 35265, the Commission granted to Arthur R. Kerstetter a license to engage in business as a motor transportation broker at Fresno, California. In this proceeding he asks the Commission to reissue that license for the year 1955.

Applicant plans to continue to arrange for transportation of general commodities intrastate within California. He is continuing to serve one carrier served during the year 1954 and has obtained Letters of Authority from two additional carriers.

After full consideration of all the evidence in this proceeding we find no reason to withhold reissuance of a license to applicant. A surety bond in the form required by law has been filed. No public hearing appears to be necessary and the application will be granted.

## ORDER

Application as above entitled having been filed, and based upon the conclusions expressed in the foregoing opinion,

IT IS ORDERED:

(1) That a license is hereby granted to Arthur R. Kerstetter to act as a motor transportation broker as defined in Section 4803

of the Public Utilities Code subject to the following conditions:

- (a) That licensee shall keep his license certificate as a motor transportation broker available at all times to public inspection.
- (b) That licensec shall conduct business as a motor transportation broker at 2100 Tulare Street, Fresno, California, and for motor carriers hereinafter named or for whom he may hereafter, from time to time, be permitted to do business by any subsequent order or orders of the Commission.

(2) That the license of said applicant shall authorize him to sell or offer for sale, negotiate for furnishing or providing transportation over the public highways of this state to be furnished only by the carriers whose names and addresses are as follows:

(3) That the Secretary of the Commission issue and deliver to said applicant a licensee certificate as a motor transportation broker in the form heretofore approved by the Commission for such license certificate and subject to the conditions hereinabove specified.
