O P I N I O N

In the above-entitled application Percy L. Musser states that he desires to continue business as a motor transportation broker for which he held license pursuant to Decision No. 49539 in Application No. 34960.

Applicant asserts that his brokerage business would be continued at two offices in Eureka, California, one at 4041 Williams Street and the other at Third and Broadway. The application contains the names of thirty-seven carriers for whom applicant desires to act as a broker. A check of the list of those carriers shows that the permit of A. F. Rodarmel has been suspended. Applicant may not serve that carrier during the suspension period. All of the remaining carriers listed have effective permits at this date.

Applicant has on file with the Commission a bond required by the provisions of Section 4838 of the Public Utilities Code. After full consideration of applicant's request it appears that the license should be renewed. A public hearing appears to be unnecessary.

O R D E R

Application therefore having been filed the Commission

being fully informed therein and good cause appearing,

IT IS ORDERED:

(1) That a license is hereby granted to Percy L. Musser to act as a motor transportation broker, as defined in Section 4803 of the Public Utilities Code, subject to the following conditions:

- (a) That said licensee shall keep his license certificate as a motor transportation broker posted at his authorized places of business so that it is readily available to public inspection at all times.
- (b) That said licensee shall do business as a motor transportation broker only at Third and Broadway, and 4041 Williams Street, Eureka, until otherwise authorized by the Commission and for motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission.

(2) That the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish or provide transportation of property over the public highways of this state, said transportation to be rendered only by the following:
