FIRST SUPPLEMENTAL ORDER

By Decision No. 51501, dated May 31, 1955, the Commission authorized Washington Water and Light Company, among other things, to issue a note in the principal amount of \$70,000 to finance a construction program as follows:

One new pumping station	\$12,500.00
3,000' of 16" Transmission line	24,000.00
One 500,000-gallon storage tank	30,000.00
Miscellaneous treatment equipment	<u>3,500.00</u>
	<u>\$70,000.00</u>

In a supplemental filing under date of August 11, 1955, the company reports that it has completed installation of the 16" transmission line and the new pumping station at costs about as estimated but that it has ascertained the development of the new well will not produce a supply of water as great as had been anticipated.

Accordingly, it has concluded to revise its construction program so as to develop a greater amount of underground supply rather than to erect a large storage tank. It reports its revised expenditures, as follows:

One new pump station	\$12,500.00
3,000' of 16" Transmission line	24,000.00
One sand trap at Well No. 2	2,500.00
One combined aerator and sand trap with pumps at Well No. 6	4,000.00
One new 1,000 g.p.m. pumping station	10,000.00
2 chlorinators for Wells No. 1 & 2	5,400.00
Replace or cement line approximately 5,000' of worn out steel pipe	<u>11,600.00</u>
	<u>\$70,000.00</u>

It is asserted that the revised program will result in an additional supply of water and an improvement in service to the public.


The Commission has given consideration to this matter and is of the opinion that a supplemental order should be entered approving the company's request as to the disposition of its note proceeds, therefore,


IT IS HEREBY ORDERED as follows:

1. The Order in Decision No. 51501, dated May 31, 1955 hereby is modified so as to permit Washington Water and Light Company to use the proceeds received through the issue of the note authorized by said decision for the purpose of meeting its revised construction program as outlined herein.


2. This First Supplemental Order is effective upon the date hereof.
