## <u>O P I N I O N</u>

C. W. Scott, A. D. Scott and Margaret Scott Chapman, co-partners, are engaged in the transportation of property in California pursuant to permits issued them by this Commission.

Applicants seek an order authorizing them to conduct service as a highway common carrier for the transportation of livestock between all points and places in the State of California.

Notice of filing of the application was given all common carriers subject to the jurisdiction of this Commission.

Upon consideration of the allegations of the application and the representations filed pursuant to the above-mentioned notice, the Commission finds that public convenience and necessity require that the application be granted. It appears that applicants possess the experience, equipment, personnel and financial resources to institute and maintain the proposed operation. A public hearing is not necessary.

Applicants are hereby placed upon notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State

as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be changed or destroyed at any time by the State, which is not in any respect limited as to the number of rights which may be given.

The Commission has considered the application and representations filed herein, Now Therefore

#### IT IS ORDERED:

(1) That a certificate of public convenience and necessity is granted to C. W. Scott, A. D. Scott and Margaret Scott Chapman, co-partners, authorizing them to operate as a highway common carrier as defined by Section 213 of the Public Utilities Code for the transportation of livestock between the points and over the routes as more particularly set forth in Appendix A attached hereto and made a part hereof.

(2) That in providing service pursuant to the certificate herein granted, applicants shall comply with and observe the following service regulations:

(a) Within thirty days after the effective date hereof, applicants shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicants are placed upon notice that they will be required, among other things, to file annual reports of their operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 99. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 99, may result in a cancellation of the operating authority granted by this decision.

(b) Within sixty days after the effective date hereof, and upon not less than five days' notice to the Commission and the public, applicants shall establish the service herein authorized and file in triplicate and concurrently make effective, tariffs satisfactory to the Commission.

The effective date of this order shall be ninety days after the date hereof.

The certificate of public convenience and necessity granted to C. W. Scott, A. D. Scott and Margaret Scott Chapman, co-partners, by the above-numbered decision, authorizes them to transport livestock between the points hereinafter described, including all intermediate points, with the right to serve off-route points within 50 miles of said routes:

- (4) U. S. Highway 97 between Weed and Dorris.
- (5) U. S. Highway 395 between San Diego and the Nevada-California State line.
- (6) U. S. Highway 395 between Nevada-California State line and the Oregon-California State line.
- (7) U. S. Highway 299 between Alturas and Redding.
- (8) U. S. Highway 36 between Johnstonville and Red Bluff.
- (9) U. S. Highway 40-A between Hallelujah Jct. and Marysville.
- (10) U. S. Highway 40 between Nevada-California State line and Berkeley.
- (11) U. S. Highway 50 between Nevada-California State line and San Francisco.
- (12) State Highway 152 between U.S. Highway 99 Jct. and Gilroy.
- (13) State Highway 41 between Yosemite and Paso Robles.
- (14) State Highway 198 between Three Rivers and San Lucas.
- (15) State Highway 63 between Auckland and Tulare.
