SUPPLEMENTAL OPINION AND ORDER

The minimum rates contained in Minimum Rate Tariff No. 2 are inapplicable to various designated carriers performing specialized or noncompetitive services. Such carriers are named in Decision No. 31606 and in numerous amendatory and supplemental decisions.¹ By reason of abandonments, transfers, additions and other changes over the years, the carrier lists are out of date and may be indefinite.

The interests of clarity and certainty will be served by setting forth hereinafter the current list of carriers exempted in whole or in part from observing the rates, rules and regulations contained in Minimum Rate Tariff No. 2. No substantive change is involved. A public hearing is not necessary.

Therefore, good cause appearing,

IT IS HEREBY ORDERED:

(1) That Decision No. 31606 in Case 4246, as amended, be and it is hereby further amended by substituting for the lists of

carriers named in Finding 14 thereof, the lists of carriers named in Appendices A, B and C (originally authorized by the decisions indicated therein), attached hereto and by this reference made a part hereof, subject to the conditions and restrictions contained in said appendices.

(2) That the exemptions authorized by the decisions indicated in Appendix D, attached hereto and by this reference made a part hereof, be and they are hereby canceled.

In all other respects said Decision No. 31606, as amended, shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.
