SECOND SUPPLEMENTAL OPINION AND ORDER

The Commission has heretofore licensed Frank D. Davi to engage in business as a motor transportation broker at 118 Harrison Street, San Francisco, California, and to furnish or provide transportation over the public highways of this state to be furnished only by the carriers heretofore designated by the Commission. (Decisions Nos. 51567 and 51993 in the above-numbered application)

By supplemental application the Commission is requested to amend that license to authorize applicant to provide transportation to be furnished by eight additional motor truck carriers.

An examination of the status of these carriers reveals that the operations of Ernest J. Spence and Joan Spence, partners, as well as that of J. Gomez are each presently suspended. Neither has on file with the Commission any evidence of public liability and property damage insurance coverage as required by law. Therefore, no authority will be issued to allow applicant to solicit traffic moved over the facilities of those two parties unless and until they lawfully resume operations. We find no cause to withhold licensing applicant to arrange transportation over the facilities of the remainder of the carriers named in the supplemental application. Therefore, and good cause appearing,

IT IS ORDERED:

(1) That the license heretofore issued to Frank D. Davi by Decision No. 51567 in this proceeding is hereby amended to authorize him to sell or offer for sale, negotiate for furnishing or providing transportation over the public highways of this state to be furnished by the additional carriers whose names and addresses are as follows:
