IT IS HEREBY ORDERED that:

- Minimum Rate Tariff No. 2 (Appendix "D" of Decision No. 31606, as amended) be and it is hereby further amended by incorporating therein, to become effective December 5, 1955, Supplement No. 29 which is attached hereto and by this reference made a part hereof.
- 2. The cancellation of the third paragraph of Item 20E of Minimum Rate Tariff No. 2 is hereby suspended until final disposition of the case of <u>United States of America</u>, <u>Plaintiff</u>, v. <u>Public Utilities Commission of the State</u> <u>of California</u>, <u>Defendant</u>, Civil Action No. 35101, now <u>pending in the United States District Court for the</u> Northern District of California, Southern Division, and until the further order of the Commission.
