SUPPLEMENTAL OPINION AND ORDER

The United States District Court for the Northern District of California, Southern Division, having issued a restraining order in the case of United States of America, Plaintiff, vs. Public Utilities Commission of the State of California, Defendant, Civil Action No. 35101, restraining the defendant Public Utilities Commission of the State of California "from taking any action or issuing any order which would interfere with the United States and the various carriers in the State of California from entering into special arrangements with respect to rates for transportation of Government property," and good cause appearing,

IT IS HEREBY ORDERED^A that:

1. Minimum Rate Tariff No. 2 (Appendix "D" of Decision No. 31606, as amended) be and it is hereby further amended by incorporating therein, to become effective December 5, 1955, Supplement No. 29 which is attached hereto and by this reference made a part hereof.
2. The cancellation of the third paragraph of Item 20E of Minimum Rate Tariff No. 2 is hereby suspended until final disposition of the case of United States of America, Plaintiff, v. Public Utilities Commission of the State of California, Defendant, Civil Action No. 35101, now pending in the United States District Court for the Northern District of California, Southern Division, and until the further order of the Commission.

This order shall become effective on the date hereof.
