SUPPLEMENTAL OPINION AND ORDER

Decision No. 52199 of November 7, 1955, in this proceeding, established a current list of carriers exempted in whole or in part from observing the rates, rules and regulations contained in Minimum Rate Tariff No. 2. It has been brought to the Commission's attention that C. R. Becker, dba Delivery Service Co. was inadvertently listed in Appendix "C" (special exemption) instead of in Appendix "A" (full exemption) as granted by Decision No. 31606. By Decision No. 51432, in Application No. 36897, the operations of C. R. Becker, dba Delivery Service Co. were transferred to Delivery Service Co., a corporation.

In addition, the operations of Max H. Green, dba Mountain Auto Line, have been transferred to W. G. Mitchell, dba Auto Fast Freight. The necessary changes will be made. A public hearing is not necessary.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Decision No. 52199 of November 7, 1955, in this proceeding, be and it is hereby amended by making the following changes in the appendices attached thereto:

- (1) Appendix "A" (Exempted in full from Observing the Rates, Rules and Regulations named in Minimum Rate Tariff No. 2).

Add: Delivery Service Co., a corporation.

- (2) Appendix "B" (Exempted from Observing the Rates, Rules and Regulations named in Minimum Rate Tariff No. 2 for shipments of 100 pounds and less).

Cancel: Max H. Green, dba Mountain Auto Line.

Add: W. G. Mitchell, dba Auto Fast Freight.

- (3) Appendix C (Special Exemption from the Rates, Rules and Regulations of Minimum Rate Tariff No. 2).

Cancel: C. R. Becker, dba Delivery Service Co.
Max H. Green, dba Mountain Auto Line.

Add: W. G. Mitchell, dba Auto Fast Freight
(Soiled laundry from Big Bear Lake and Lake Arrowhead Village to San Bernardino and Redlands at not less than 25 cents per 100 pounds).

In all other respects said Decision No. 52199 shall remain in full force and effect.


This order shall become effective twenty days after the date hereof.
