O P I N I O N

In the above-entitled application Frank D. Davi requests the Commission to issue to him a new license for the year 1956 to continue his business as a motor transportation broker. Applicant was first licensed as a broker by Decision No. 49868, dated March 30, 1954, in Application No. 34879. That license was renewed for the year 1955 by Decision No. 51567 in Application No. 36582.

Letters of authority from approximately 30 motor carriers have heretofore been filed with the Commission by applicant. The Commission's records show that two of the carriers for whom applicant desires to sell transportation are not operating at this time, their permits having been suspended. Another carrier, L. W. Koerner, as of November 1, 1955, was authorized to sell his permits. Consequently those names will be withheld from the list of carriers which applicant may serve. Applicant has on file with the Commission a surety bond continuous in form as required by the provisions of Section 4838 of the Public Utilities Code.

After full consideration of applicant's request it appears at this time that his license for the calendar year of 1956 should be renewed. A public hearing appears to be unnecessary.

O R D E R

Application as above entitled having been filed, and based upon the conclusions expressed in the foregoing opinion,

IT IS ORDERED:

(1) That a license is hereby granted to Frank D. Davi to act as a motor transportation broker as defined in Section 4803 of the Public Utilities Code subject to the following conditions:

- (a) That licensee shall keep his license certificate as a motor transportation broker available at all times to public inspection.
- (b) That licensee shall conduct business as a motor transportation broker at 1188 Harrison Street, San Francisco, California, and for motor carriers hereinafter named or for whom he may hereafter, from time to time, be permitted to do business by any subsequent order or orders of the Commission.

(2) That the license of said applicant shall authorize him to sell or offer for sale, negotiate for, furnish or provide transportation for property over the public highways of this State to be furnished only by the motor carriers whose names and addresses are as follows:
