O P I N I O N

By Decision No. 51576 the Commission granted to Arthur R. Kerstetter a license to engage in business as a motor transportation broker at Fresno, California. That license having expired he asks the Commission to issue a new license to him for the year 1956.

Applicant would continue to arrange for transportation of general commodities intrastate within California. He plans to serve the same carriers used during the year 1955 and has obtained a letter of authority to serve one additional carrier.

After full consideration of all the evidence in this proceeding we find no reason to withhold issuance of the new license sought by applicant. A surety bond in the continuous form required by law is on file with the Commission. No public hearing appears to be necessary and the application will be granted.

O R D E R

Application as above entitled having been filed and based upon the conclusions expressed in the foregoing opinion,

IT IS ORDERED:

(1) That a license is hereby granted to Arthur R. Kerstetter to act as a motor transportation broker as defined in Section 4803 of the Public Utilities Code subject to the following conditions:

- (a) That licensee shall keep his license certificate as a motor transportation broker available at all times to public inspection.
- (b) That licensee shall conduct business as a motor transportation broker at 2100 Tulare Street, Fresno, California, and for motor carriers hereinafter named or for whom he may hereafter, from time to time, be permitted to do business by any subsequent order or orders of the Commission.

(2) That the license of said applicant shall authorize him to sell or offer for sale, negotiate for, furnish or provide transportation over the public highways of this state to be furnished only by the motor carriers whose names and addresses are as follows:

(3) That the Secretary of the Commission issue and deliver to said applicant a licensee certificate as a motor transportation broker in the form heretofore approved by the Commission for such

license certificate and subject to the conditions hereinabove specified.

The effective date of this order shall be twenty days after the date hereof.
