O P I N I O N

Pacific Greyhound Lines in the above-entitled application requests authority to operate over an additional urban route in Santa Ana. Specifically, it requests authority to operate over Bush Street between its intersection with Third Street and the intersection of First and Spurgeon Streets.

As justification for the authority sought the application states that Spurgeon Street, by municipal ordinances, has been designated as a one-way street for northbound traffic only, and Bush Street has been designated as a one-way street for southbound traffic only. Heretofore applicant has used Spurgeon Street for its operation in both directions.

After full consideration of applicant's request the Commission finds that public convenience and necessity require the establishment of service over the additional route as proposed. There is no protest to the application and a public hearing does not appear to be necessary. The application will be granted.

O R D E R

An application therefor having been filed, the Commission being fully informed therein and it having been found that public convenience and necessity so require,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity is hereby granted Pacific Greyhound Lines authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, their baggage and express, between the points and over the route as set forth in Route No. UR-16.04, appearing on Third Revised Page 83, attached hereto as Appendix A, as an extension and enlargement of, consolidated with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 47907.

(2) That Appendix A of Decision No. 47907, Application No. 31883, is hereby amended by incorporating therein Third Revised Page 83, referred to in paragraph (1) of this order.

(3) That in providing service pursuant to the certificate herein granted applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, appropriate tariffs and timetables.

The effective date of this order shall be twenty days after the date hereof.

- UR-16.02 - From the junction of Third Street and North Main Street, over Third Street to its junction with Spurgeon Street.
- UR-16.03 - From the junction of Second Street and Spurgeon Street, over Spurgeon Street to First Street to U. S. Highway 101 to the eastern city limits of Santa Ana.
- *UR-16.04 - From the junction of Third Street and Bush Street, over Bush Street to First Street to Spurgeon Street.
