$\frac{\text { OPINION AND ORDER AMENDING THE ORDER }}{\text { OF DECISION NO. } 52487}$

By Decision No. 52487, deted January 16, 1956, in Appilcation No. 37369, applicent John Jervik doing business as Desert Hot Springs Stage Iines was given authority as a passenger stage corporation to cerry passengers betweun Desurt Hot Springs, on the one hand, and the intersection of Ramon Rosd and Sunrise Eighwey in the City of Palm Springs, California, on the other hand.

By Petition Eor Modification of said decision, filed with this Commission on Februery 2, 1956, John Jorvik alleges that the Palm Springs terminus of the inne wes pleced at the intersaction of Ramon Road and Sunrise Highway for the reason that at the time of the hearing or the application the applicant believed thet a Cathoilc school which he dusires to survo was loceted at thet intersoction, and that subsequantly ho hes boen apprised of the fact that the school is at the intersection of Ramon Road and Compadxa Road in Palm Springs, a point approximately $3 / 4$ of a mile oast of the authorized torminus at Ramon Roed and Sunrise

HIghway. Appiscant requests that the routing authorized by Decision No. 52487 be modified by extending the route from the intersection of Ramon Road and Sunrise Highway via Ramon Road to Compadre Road:

John Jervik, Going business as Desort Hot Springs Stage Ines, by the certificate of public convenience and necessity granted in the above-mentioned decision, is authorized to transport persons between Desert Hot Springs, on the ore hand, and the City of Palm Springs, on the other hand, and intermediate points, subject to the following conditions and restrictions:
(1) On trips from Desert Fot Springs to Palm Springs applicant shall pick up no passengers between North Palm Springs exclusive of North Palm Springs ond the terminus of the inne at the intersection of Ramon Road and Compadre Road, in Palm Springs.
(2) On trips from Palm Springs to Desert Hot Springs applicant shali discharge no passengers betweon the terminus of the ilne at the intersection of Ramon Road and Compadre Road in Palm Springs, and North Palm Springs, exclusive of North Palm
Springs.

Subject to the authority of the commission to change or modify such at any time, John Jervik, doing business as Desert Eot Springs Stage Ines, shall conduct said passenger stage operation over and along the rollowing described route:

From the intersection of pierson Boule varc and Palm Drive in Desert Hot Springs, via Pierson Boulevard, Ocotil10 Drive, Eighth Streot, Palm Drive, Diljon Road, Indian Avonue, and Ramon Road to its intersection with Compadre Road in

Applicant is authorized to turn its motor Vehicles at termini and intermediate points In either airection, at intorsections of streets or by operating around a block contiguous to such intorsections, or in accordance with local trafifc rujos.
