O P I N I O N

Helen C. McQuiggan, Administratrix of the Estate of Nicholas Capraro doing business as Palo Alto Transit, requests permission to extend several passenger stage routes in the Monte Vista, Los Altos and Cupertino areas.

As justification for the authority sought, applicant alleges that the proposed extensions will provide service to newly developed residential areas.

After consideration, the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought.

O R D E R

Application having been filed and the Commission having been informed in the premises;

IT IS ORDERED:

- (1) That a certificate of public convenience and necessity is hereby granted to Helen C. McQuiggan, Administratrix of the Estate of Nicholas Capraro doing business as Palo Alto Transit, authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the points and over the routes hereinafter set forth.

- a. Commencing at the intersection of Stevens Creek Road and South Blaney Avenue, thence along South Blaney Avenue to Bollinger Road, Johnson Avenue, Wunderlich Drive, Tilson Avenue, Stern Avenue, Loree Avenue, Judy Avenue to the intersection with Stevens Creek Road.
- b. Commencing at the intersection of Stevens Creek Road, Mountain View Road and Homestead Road, thence along Homestead Road to Stelling Road to the intersection with Stevens Creek Road.
- c. Commencing at the intersection of Grant Road and Farndon Avenue, thence along Farndon Avenue to Crist Drive, Morton Avenue to the intersection with Grant Road.

(2) That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following regulations:

- a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- b. Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective, appropriate tariffs and timetables.

The effective date of this order shall be twenty days after the date hereof.
