O P I N I O N

Decision No. 48718 in Application No. 34135, amended by Decision No. 50562 in Application No. 35726, authorized applicant to operate the No. 10 State College Route commencing at the intersection of Fresno Street and Van Ness Avenue, thence along Van Ness Avenue, Mariposa Street, Fulton Street, Fresno Street, North Fresno Street, North Fresno Avenue, East Ashcroft Avenue, North Augusta Avenue, East Holland Avenue, North Fresno Avenue, Shaw Avenue to the entrance of the Fresno State College.

Applicant alleges that the present routing of the No. 10 State College Line has proven adequate until the week of May 20, when the new Sears Roebuck store located in the shopping area of Manchester Park, which is at the northwest corner of the intersection of Shields and Blackstone Avenues, was opened for business.

Applicant requests authority to extend the No. 10 State College Line to more adequately serve this shopping area.

There will be no change in rates of fare. Zone 1 will extend to North Fresno Avenue and Ashlan Avenue. Zone 2 will apply to all points beyond North Fresno and Ashlan Avenues for passengers paying adult fares. Applicant's Local Passenger Tariff No. 10 now in effect and on file with the Commission will prevail.

The proposed service is within applicant's service area and will affect no other carrier. The applicant indicates that copies of

said application were sent to all interested parties including City Commission, County Commission, Fresno Bee, Fresno Guide and Moyers Stages. A public hearing is unnecessary.

ORDER

Application therefore having been filed, the Commission being fully informed and finding that public convenience and necessity so require,

IT IS ORDERED:

That the route description in ordering Paragraph 3 (c) of Decision No. 48718 in Application 34135 and further amended by Decision No. 50562 in Application No. 35726, be and it hereby is amended by adding thereto the following route description:

Also along Shields Avenue between North Fresno Avenue and Blackstone Avenue, along Blackstone Avenue between Shields Avenue and Dakota Avenue and along Dakota Avenue between Blackstone Avenue and Shields Avenue.

The effective date of this order shall be the date hereof.
