K. Trucking Co., is engaged in the transportation of property in California pursuant to permits and certificates of public convenience and necessity issued by this Commission. Applicant seeks an order authorizing it to conduct service as a highway common carrier for the transportation of general commodities between San Francisco Territory, Sacramento and Los Angeles Basin Territory and intermediate points. Notice of the filing of the application was given all common carriers subject to the jurisdiction of this Commission. Upon consideration of the allegations of the application and the representations filed pursuant to the above-mentioned notice, the Commission finds that public convenience and necessity require that the application be granted to the extent set forth in the ensuing It appears that applicant possesses the experience, equipment, order. personnel and financial resources to institute and maintain the operation authorized herein. A public hearing is not necessary. Applicant is hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive -1(b) Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs satisfactory to the Commission.

The effective date of this order shall be ninety days after the date hereof.
