ORDER MODIFYING DECISION NO. 53329

Louis Bartlett, one of the applicants herein, has petitioned for modification of paragraph 8 of the order in Decision No. 53329, issued herein on July 10, 1956. That decision, among other matters, authorized certain transfers of operative rights and utility properties, resulting in the acquisition by Pinewood Water Company, a corporation, of two adjacent water systems near Bijou, El Dorado County, California.

Paragraph 8 of the order in said decision required Pinewood Water Company to file a map showing the location of the various portions of the water systems and facilities involved, "including the location of the connection to the Lakeside Spring".

As was pointed out in other parts of Decision No. 53329, no Lakeside Spring water was included or involved in any part of the transfer of the Pinewood Terrace system therein authorized. Petitioner alleges that no Lakeside Spring water is to be delivered to the

Pinewood Water Company system and that there will be no connection between the Lakeside Spring system and the Pinewood Water Company system.

It appears that no necessity exists for including any reference to Lakeside Spring on the map which Pinewood Water Company has been directed to file by paragraph 8 of the order in said Decision No. 53329. Accordingly, the reference to Lakeside Spring should and will be deleted from said paragraph 8 of said order.

Therefore, good cause appearing, IT IS ORDERED that the petition of Louis Bartlett, filed herein on July 26, 1956, be, and it is hereby, granted, and that paragraph 8 of the order in said Decision No. 53329 be, and it hereby is, modified by deleting therefrom the following phrase - "including the location of the connection to the Lakeside Spring".

Except as herein modified, said Decision No. 53329, in all other respects, shall be and remain in full force and effect.
