## APPENDIX A      PACIFIC GREYHOUND LINES

Third Revised Page 58-A

- \*17.28 - Between the junction of U. S. Highway 101 and Santa Clara Avenue, Santa Ana, and the junction of relocated U. S. Highway 101 and Laguna Road, southeast of Tustin:

From the junction of U. S. Highway 101 and Santa Clara Avenue, over relocated U. S. Highway 101 to junction Laguna Road, to be operated as an alternate route.

- 17.29 - Between the junction of By-Pass U. S. Highway 101 and California Highway 39, and the junction of La Palma Avenue and By-Pass U. S. Highway 101:

From the junction of By-Pass U. S. Highway 101 and California Highway 39, over California Highway 39 to junction La Palma Avenue (Knott's Berry Farm), thence over La Palma Avenue to junction By-Pass U. S. Highway 101, to be operated on call to and from Knott's Berry Farm for 25 or more adult fares.

- 17.30 - Between the junction of By-Pass U. S. Highway 101 and Harbor Boulevard, and Disneyland:

From the junction of By-Pass U. S. Highway 101 and Harbor Boulevard, over Harbor Boulevard to Disneyland, to be operated on call to and from Disneyland for 25 or more adult fares.

- \*\*17.31 - Between the junction of Main Street and National Avenue and the junction of Main Street and U. S. Highway 101:

From the junction of Main Street and National Avenue, over Main Street to junction of Main Street and U. S. Highway 101, to be operated as an alternate route.
