1. DAIRY PRODUCTS, VIZ.:
  - Butter
  - Butterfat or cream
  - Buttermilk
  - Milk or cream
2. FOOD STUFFS, BEVERAGES OR BEVERAGE PREPARATIONS, not named in other more specific groups, VIZ.:
  - Cream, sterilized
  - Milk albumen
  - Milk beverage
  - Milk, cream, buttermilk or milk solids
  - Milk food
  - Milk or buttermilk, condensed or evaporated
  - Milk, sterilized
  - Whey
3. MISCELLANEOUS COMMODITIES, VIZ.:
  - Cans, cream or milk shipping
  - Casein
  - Ice

## BETWEEN:

- A. Gustine, on the one hand, and Patterson, Los Banos, Visalia, Hanford, Modesto, Newman, San Luis Obispo and Los Angeles, on the other hand.
- B. Los Banos, on the one hand, and Galt, Hanford, Los Angeles, Manteca and Salinas, on the other hand.
- C. Newman, on the one hand, and Patterson and Stockton, on the other hand.
- D. Paso Robles, on the one hand, and Compton and Ripon, on the other hand.
