Applicant seeks an order authorizing him to conduct service as a highway common carrier for the transportation of specifically named commodities, generally between Los Angeles and San Francisco, Los Angeles and Pittsburg, Los Angeles and Sacramento, Los Angeles and San Diego, Los Angeles and El Centro, Los Angeles and Long Beach, and intermediate and off-route points.

Notice of filing of the application was given all common carriers subject to the jurisdiction of this Commission.

A public hearing was held at Los Angeles on September 27, 1956 before Examiner Carl Silverhart.

Protestants did not offer testimony but engaged in cross-examination of applicant.

Upon consideration of the allegations of the application, the representations filed pursuant to the above-mentioned notice

- (2) That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
 - (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that he will be required, among other things, to file annual reports of his operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 99. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 99, may result in a cancellation of the operating authority granted by this decision.
 - (b) Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs satisfactory to the Commission.

The effective date of this order shall be ninety days after the date hereof.

Appendix A Carl Albin Original Page 1 Carl Albin, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport general commodities between: 1. All points in the Los Angeles area more particularly delineated in Appendix B attached hereto. Such Los Angeles area, on the one hand, and San Diego, on the other hand. The authority set forth in this paragraph 2 does not include the right to render service to, from or between points intermediate to such area and San Diego. Applicant shall not transport any shipments of: 1. Used household goods and personal effects not packed in accordance with the crated property requirements set forth in paragraph (d) of Item No. 10-C of Minimum Rate Tariff No. 4-A. 2. Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis. 3. Livestock, viz.: bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags or swine. 4. Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerated equipment. 5. Liquids, compressed gases, commodities in semi-plastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles. 6. Commodities when transported in bulk in dump trucks or in hopper-type trucks. 7. Commodities when transported in motor vehicles equipped for mechanical mixing in transit. Highway No. 66 to the west bank of the San Gabriel River; southerly along the west bank of the San Gabriel River to Beverly Boulevard; southeasterly on Beverly Boulevard to Painter Avenue in the City of Whittier; southerly along Painter Avenue to U. S. Highway No. 101; southeasterly and southerly along U. S. Highway No. 101 to U. S. Highway No. 101, Bypass; southeasterly along U. S. Highway No. 101 Bypass; southeasterly along U. S. Highway No. 101 Bypass; to First Street. Westerly along First Street.
