Nature of Proceeding

By the above-entitled application, filed December 1, 1955, Planada Water Company, a California corporation, seeks an order of this Commission granting to it a certificate of public convenience and necessity and authority to establish increased rates for water service rendered in Planada, Merced County:

Public Hearing

Public hearing in the matter was held before Examiner John M. Gregory on June 25, 1956, at Planada. At the hearing applicant filed an amendment to the application by which it proposed a simplified rate structure. The matter was submitted, on receipt of a copy of an amendment to applicant's articles of incorporation on August 13, 1956.

The Applicant and System Development

Applicant was organized in 1912 for the purpose of furnishing water to an area of about 290 acres laid out and subdivided by the Planada Development Company during the preceding year. Applicant's authorized capitalization was \$50,000 represented by 500 shares of \$100 par value stock. The original town is said to have

been a "boom town" type of development which soon experienced a substantial decline in population. At the town's lowest ebb in 1934, a Mr. W. B. Fugh of Planada purchased 303 of the 305 outstanding shares of stock of the water company and took over the operation of the system serving such customers who happened to be connected to the system and charging nominal rates for such service. Upon the death of Mr. Pugh, Mrs. Fugh continued the operation until 1946 when the stock was transferred to Wm. H. and Margaret E. Houlihan, applicant's present president and secretary.

In recent years Planada has grown from a village of a few hundred people to a town of approximately 2,000. Until very recently many residents obtained their water supply from individual wells. Because of the increased population many of the individual wells became contaminated due to lack of proper sewage disposal. Applicant's source of supply comes from deep wells completely free from surface contamination and under permit from the State Department of Public Health. Applicant now supplies water to approximately 400 customers and anticipates a normal growth as more individuals transfer their supply from private wells to the utility system.

The water supply for this system is obtained from two wells located within the area served. These wells are 350 and 510 feet deep and are 12 and 14 inches in diameter, respectively. A third well owned by the utility but which is not presently equipped with pump or motor, and a privately owned well which is fully equipped and connected to the utility system, are available to augment the water supply if needed. Each of the two wells presently in use is equipped with a 20-hp electric motor directly connected to a deep well turbine pump. The two pumping plants are capable of delivering a total of approximately 750 gallons of water per minute. A pressure tank of 1200-gallon capacity and a 25,000-gallon elevated redwood tank

maintain the system pressure between 20 and 30 pounds per square inch. The distribution system consists of approximately 8,600 feet of 6-inch, 16,300 feet of 4-inch, and 12,100 feet of 2-inch diameter steel pipe installed at various times since 1912. As of December 31, 1955, there were 367 customers receiving water service.

Applicant's system is the only utility water system within 6 miles of the area.

Rate Proposal

Applicant's present basic flat rate is \$2 per month. To such basic charge, however, are added any of a large number of various other charges based upon the type of appliances used or the type of premises served. Under existing rates, the average residential customer pays approximately \$28.37 annually and the average business customer pays approximately \$34.12 annually.

Applicant's proposed basic flat rate is \$3.50 per month for residential service and \$3 per month for business service with various additional charges as before. Under the proposed rates the average residential customer would pay approximately \$53.84 annually, while the average business establishment would pay approximately \$51 annually.

Applicant now has no meters in service but proposes to meter the larger water users in the future.

Results of Operations

The evidence respecting the results of applicant's operations discloses the following estimates for the current year's operations:

The evidence is clear, as the above tabulation illustrates, that applicant's present rates do not produce sufficient revenue to meet operating expenses, let alone provide a return on the investment in water plant. Applicant's proposed rates, on the other hand, would produce an excessive rate of return. Applicant is in need of and entitled to increased revenues but not to the extent sought. Applicant will be authorized to file rates which will produce annual gross revenues of \$17,670. After allowance of \$14,310 for all reasonable operating expenses, including taxes and depreciation, a net revenue of \$3,360 will result. Such net revenue when related to a fair and reasonable rate base of \$51,354 will yield a rate of return of approximately 6.5 per cent, which rate of return we also find to be fair and reasonable.

<u>Conclusions</u>

In view of the evidence we find that public convenience and necessity require and will require that applicant be granted a certificate for the area requested. Such certificate is subject to the following provision of law:

> That the Commission shall have no power to authorize the capitalization of this certificate of public convenience or the right to own, operate or enjoy such certificate of public convenience or necessity in excess of the amount (exclusive of any tax or annual charge) actually paid to the State as the consideration for the issuance of such certificate of public convenience and necessity or right.

We find that the increases in rates and charges authorized herein are justified and that existing rates and charges, in so far as they differ from those authorized herein, are for the future unjust and unreasonable.

<u>ORDER</u>

Public hearing having been held, the matter having been submitted and based upon the evidence and findings and conclusions contained in the foregoing opinion,

IT IS ORDERED that a certificate of public convenience and necessity be and it is hereby granted to Planada Water Company to construct, operate and maintain a public utility water system for the production, storage, distribution and sale of water within the territory delineated on the map designated Exhibit No. 3 in this proceeding.

IT IS HEREBY FURTHER ORDERED as follows:

1. Applicant is authorized and directed to file in quadruplicate with this Commission the schedules of rates set forth in Appendix A attached to this order, together with rules and tariff service area map acceptable to this Commission and in accordance with the provisions of General Order No. 96. Such rates, rules and tariff service area map shall become effective on January 16, 1957 on not less than five days' notice to the public and to this Commission after filing as hereinabove provided.

2. Within thirty days after the effective date of this order, applicant shall file with this Commission four copies of a comprehensive map, drawn to an indicated scale of approximately 400 feet to the inch, delineating by appropriate markings the various tracts of land and territory served for which this certificate is issued, such map also showing the principal water production, storage and distribution system and the various properties of applicant.

3. Beginning with the year 1956, applicant shall determine depreciation expense by multiplying depreciable fixed capital by a rate of 2.2 per cent until such time as review indicates that such rate should be revised. A review of the depreciation rate, using the straight-line remaining life method of computation, shall be made whenever substantial changes in depreciable fixed capital occur and at intervals of not more than five years. Results of such reviews shall be submitted to this Commission.


