OPINION AND ORDER

By first supplemental application, filed November 5, 1956, in the above-entitled matter, Pacific Gas and Electric Company, 1 a corporation, requests authority of the Commission to carry out the terms of an agreement, dated August 23, 1956, with Willard Kingsford and Verna Kingsford 2 and Emory K. Underwood 2 . A copy of the said agreement is attached to the first supplemental application as Exhibit No. 2.

Pacific was authorized by Decision No. 46464 in Application No. 32859 to carry out the terms and conditions of a written contract, dated October 3, 1951, providing for the furnishing of water service to Kingsfords. A copy of the above-mentioned contract, dated October 3, 1951, attached to Application No. 32859 as Exhibit No. 1, includes a provision which prohibits Kingsfords from assigning any interest therein to any other party without first having obtained the written consent of Pacific.

It is stated in this first supplemental application that, Verna Kingsford having died, Willard Kingsford sold to Underwood the

lands described in the contract dated October 3, 1951, and subserquently, on August 23, 1956, Pacific, Willard Kingsford and Underwood entered into an agreement whereby Willard Kingsford assigned to Underwood all of his rights and interest in the previous contract.

The Commission having considered the request of applicant and being of the opinion that the request should be granted and that a public hearing is not necessary; therefore,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company be and it is authorized to carry out the terms and conditions of the written agreement dated August 23, 1956, with Emory K. Underwood and Willard Kingsford under the terms and conditions stated therein, and

IT IS HEREBY FURTHER ORDERED that:

- l. Pacific Gas and Electric Company shall file with this Commission, within thirty days after the effective date of this order, two certified copies of the agreement as executed, together with a statement of the date on which the agreement is deemed to have become effective.
- 2. Pacific Gas and Electric Company shall notify this Commission of the date of the termination of said agreement within thirty days after said date of termination.

The effective date of this order shall be twenty days after the date hereof.
