OPINION

In the above-entitled application Percy L. Musser states that he desires to continue business as a motor transportation broker for which he has received licenses from this Commission from December 9, 1952 to and including December 31, 1956. His license for the year 1956 was granted pursuant to the Commission's Decision No. 52669 in Application No. 37445.

Applicant asserts that he would continue his brokerage business at two offices in Eureka, California, one at 4041 Williams Street and the other at Third and Broadway.

The application contains a list of names of 87 motor carriers for whom applicant desires to act as a broker. Forty-nine of these are new carriers from whom applicant has received letters of authority to sell transportation, which are attached to the application herein. Letters of authority from the other carriers are attached to former applications of applicant on file with the Commission. An analysis of the list of the carriers shows that the permits of the following carriers have been revoked and have not been renewed:

A-38634 GF Therefore, the names of the above-mentioned carriers will be withheld from the list of carriers which applicant may serve. All of the remaining carriers have effective permits as of this date. After full consideration of all of the evidence in this proceeding, we find no reason to withhold issuance of a new license sought by applicant for the year 1957. Applicant has on file with the Commission a bond required by the provisions of Section 4838 of the Public Utilities Code, which is continuous in form. No public hearing appears to be necessary and the application will be granted. ORDER An application therefor having been filed, the Commission being fully informed therein and good cause appearing, IT IS ORDERED: That a license is hereby granted to Percy L. Musser to act as a motor transportation broker as defined in Section 4803 of the Public Utilities Code, subject to the following conditions: (a) That said licensee shall keep his license certificate as a motor transportation broker posted at his authorized places of business so that it is readily available to public inspection at all times. That said licensee shall do business as a motor transportation broker only at Third and Broadway, and 4041 Williams Street, Eureka, until otherwise authorized by the Commission and for motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission. That the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish or provide transportation for property over the public highways of this state, -2-

said transportation to be rendered only by the following motor carriers:
