SUPPLEMENTAL ORDER

Consolidated Freightways, Inc., having filed a petition for reconsideration of Decision No. 51614, and the Commission finding that public convenience and necessity require that such petition be granted as hereinafter set forth,

Therefore, IT IS ORDERED:

(1) That Decision No. 51614, dated June 28, 1955, in Application No. 35940, is vacated and set aside.

(2) That a certificate of public convenience and necessity is granted to Consolidated Freightways, Inc., a corporation, authorizing it to operate as a highway common carrier as defined by Section 213 of the Public Utilities Code for the transportation of property between the points and over the routes as more particularly set forth in Appendix A attached hereto and made a part hereof.

(3) That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules

and other regulations of the Commission's General Order No. 99. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 99, may result in a cancellation of the operating authority granted by this decision.

- (b) Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs satisfactory to the Commission.

The effective date of this order shall be twenty days after the date hereof.

- (f) State Highway 49 between Sattley and Mariposa.
- (g) State Highway 127 between the California-Nevada state line and Baker.
- (h) U. S. Highway 299 between U. S. Highway 101 approximately two miles north of Arcata and Alturas.
- (i) U. S. Highway 40 between San Francisco and the California-Nevada state line.
- (j) State Highway 190 between U. S. Highway 395 two miles south of Lone Pine and Death Valley Junction.
- (k) U. S. Highway 466 between State Highway 1 near Morro Bay and the California-Nevada state line.
- (l) U. S. Highway 66 between Santa Monica and the California-Arizona state line.
- (m) U. S. Highway 60 between Los Angeles and the California-Arizona state line.
- (n) U. S. Highway 80 between San Diego and the California-Arizona state line.
