#### ORDER DISCONTINUING PROCEEDINGS

On February 27, 1956, the Supreme Court of the United States rendered decisions in <u>United Gas Pipeline Company v. Mobile</u> Gas Service Corporation and Federal Power Commission v. Mobile Gas Service Corporation, Nos. 17 and 31, October Term, 1955, and Federal Power Commission v. Sierra Pacific Power Company, and Pacific Gas and Electric Company v. Sierra Pacific Power Company, Nos. 51 and 53, October Term, 1955, the effect of which decisions was to raise certain questions respecting the jurisdiction of the Federal Power Commission to accept for filing and review the increased gas rate schedules of El Paso Natural Gas Company involved in Federal Power Commission Docket No. G-2018 and Docket No. G-4769. On March 20, 1956, this Commission (the California Public Utilities Commission) issued orders in each of the proceedings herein reopening such proceedings for further hearing for the purpose of determining whether any or all of the following decisions of this Commission granting applicants increases in gas rates to offset contingent increases in the cost of gas purchased by them from El Paso Natural Gas should be modified: Decision No. 48484 issued April 14, 1953, in Application No. 34107; Decision No. 50744 issued November 4, 1954, in Application No. 35256, as amended. by Decision No. 51126 issued February 23, 1955; Decision No. 51360 issued April 19, 1955, in Application No. 36635; Decision No. 47992 issued December 2, 1952, in Application No. 33700; Decision No. 51359 is sued April 19, 1955, in Application No. 34975 (Second Supplemental); Decision No. 47991 issued December 2, 1952, in Application No. 33699; and Decision No. 51361 issued April 19, 1955, in Application No. 35742 (Second Supplemental).

By Decision No. 53194 issued June 4, 1956, herein, the Commission (1) found that none of the decisions previously issued

in these proceedings should be modified, (2) discontinued these proceedings in so far as matters pertaining to Federal Power Commission Docket No. G-2018 are concerned, and (3) held the proceedings open for later consideration of the matters herein pertaining to Federal Power Commission Docket No. G-4769.

This Commission has participated in the hearing on Federal Power Commission Docket No. G-4769 which has now been taken under submission by the Federal Power Commission. During the course of such hearing neither this Commission nor any other party raised any issue respecting the jurisdiction of the Federal Power Commission to accept for filing and review the increased gas rate schedules of El Paso Natural Gas Company in Docket No. G-4769 by reason of the decisions of the United States Supreme Court referred to above.

Good cause therefor appearing,

IT IS HEREBY ORDERED that the proceedings herein are also discontinued in so far as jurisdictional matters pertaining to Federal Power Commission Docket No. G-4769 are concerned.
