O P I N I O N

Stockton City Lines, Inc., presently rendering a passenger stage service in the City of Stockton and areas immediately adjacent thereto, requests a new certificate redesccribing its operating authority.

As justification for the authority sought applicant alleges that from time to time various amendments and extensions of its routes have been made and that a certificate setting forth the routes in separate looseleaf form would facilitate future amendments and thus be more convenient.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought. A public hearing does not appear to be necessary.

O R D E R

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED that:

1. In the place and stead of its existing operative authority a certificate of public convenience and necessity is hereby granted to Stockton City Lines, Inc., authorizing the transportation of

passengers between the points and over the routes set forth in Appendix A attached hereto and by reference made a part hereof.

2. In providing service pursuant to the authority herein granted, applicant shall comply with and observe the following service regulations:

- a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted;
- b. Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and the public, applicant shall establish the service authorized and file in triplicate and concurrently make effective appropriate tariffs and timetables.
