SUPPLEMENTAL OPINION AND ORDER

By Decision No. 54690, entered today in Petition for Modification No. 21 in Case No. 5441, it was found that the title pages of Section 5 of City Carriers' Tariff No. 1-A and of City Carriers' Tariff No. 2-A - Highway Carriers' Tariff No. 1-A should be amended by the addition thereto of a provision reading as follows:

"The rates and charges in this section will not apply for services for which rates and charges are provided in Items Nos. 220, 221 and 222 series of this tariff."

It was also found that the necessary amendment of City Carriers' Tariff No. 2-A - Highway Carriers' Tariff No. 1-A should be made by a separate order.

Therefore, good cause appearing,

IT IS ORDERED that City Carriers' Tariff No. 2-A - Highway Carriers' Tariff No. 1-A (Appendix "A" of Decision No. 41362 as amended) be and it is hereby further amended by incorporating therein, to become effective May 1, 1957, First Revised Page 46 Cancels Original Page 46, which page is attached hereto and by this reference made a part hereof.

IT IS FURTHER ORDERED that tariff publications to be made by common carriers pursuant to this order may be made effective on not less than five days' notice to the Commission and to the public.

In all other respects the aforesaid Decision No. 41362, as amended, shall remain in full force and effect.

The effective date of this order shall be twenty days after the date hereof.
