SUPPLEMENTAL ORDER

By Decision No. 54391 dated January 15, 1957, in Application No. 38547, the Commission authorized Earl C. Cook and Eva M. Cook, doing business as Cook's Stages, to extend service to Kern County General Hospital in the City of Bakersfield. No authority to provide a local service along the extended route was granted. In order to clarify the authority granted in this respect the decision will be amended to provide for an appropriate restriction.

IT IS ORDERED that Second Revised Page 4 attached hereto is hereby substituted in place of First Revised Page 4 attached to Decision No. 54391 dated January 15, 1957, in Application No. 38547.

5. Between Bakersfield and Arvin:

From Bakersfield, over U. S. Highway 466 (Edison Highway) and Weedpatch Highway to junction Di Giorgio Road (Lamont), thence over Di Giorgio Road to junction Tejon Highway, thence over Tejon Highway to Arvin.

Restriction: No passenger shall be transported whose origin and destination are both within the corporate limits of the City of Bakersfield.

6. Between Lamont and Reber:

From Lamont, over Weedpatch Highway, Sunset Boulevard and Edison Road to junction Di Giorgio Road (Reber).

7. Between Weedpatch and junction Buena Vista Boulevard and Edison Road:

From junction Weedpatch Highway and Buena Vista Boulevard (Weedpatch), over Buena Vista Boulevard to junction Edison Road.

8. Between the junction of U. S. Highway 466 (Edison Highway) and Fairfax Road, and the junction of Redbank Road and Weedpatch Highway:

From the junction of U. S. Highway 466 (Edison Highway) and Fairfax Road, over Fairfax Road and Redbank Road to junction Weedpatch Highway.

9. Between Bakersfield and the junction of U. S. Highway 466 (Edison Highway) and Oswell Street via the Kern County General Hospital:

From the junction of U. S. Highway 466 (Edison Highway) and Oswell Street thence along Oswell Street, Niles Street, Mt. Vernon Avenue, Flower Street, Baker Street, Niles Street, Union Avenue, 21st Street, N Street to its intersection with 19th Street.

Restriction: No passenger shall be transported whose origin and destination are both between Bakersfield terminal and the junction of U. S. Highway 466 (Edison Highway) and Oswell Street, intermediate points inclusive.
