OPINION

Applicants Rice and Murry are common carriers of passengers by bus in the City of Merced and between points in the surrounding unincorporated areas, under Commission authority. Application No. 38986 filed April 15, 1957, contains the allegation that due to extensive street construction in Merced certain changes in routes were made and because the route as thus modified better met the needs of the public it was sought to be authorized on a permanent basis. A copy of this application was served upon the city manager. No protests have been filed objecting to the routes as modified. The Commission finds that the proposed route changes are in the public interest and will be authorized. A public hearing is unnecessary.

Route 3 - MERCED TO YOSEMITE LAKE

Over and along Six Mile Grade, Yosemite Road and Bellevue Road.

IT IS FURTHER ORDERED that within sixty days after the effective date hereof and on not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized.

The effective date of this decision shall be twenty days after the date hereof.
