O P I N I O N

Applicant requests authority to make a minor change in its route on Line 90, Sherman Oaks-Van Nuys-Canoga Park. It alleges that the proposed routing is in the public interest for the following reasons: at the present time Line 90 motor coaches destined to Canoga Park make a near-side passenger stop on Van Nuys Boulevard at Vose Street, and, within a distance of 244 feet, cross from the curb line to the fourth traffic lane in order to make a left turn into Sherman Circle; this left-turning traffic must make a boulevard stop before crossing the three southbound traffic lanes on Van Nuys Boulevard, and must make another boulevard stop at Sherman Way; and vehicular traffic on Sherman Way at this point is heavy and fast moving, making the entry into Sherman Way at an angle extremely hazardous.

The new outbound route from Ventura Boulevard and Van Nuys Boulevard will be via Van Nuys Boulevard and Sherman Way to Topanga Canyon Boulevard. Inbound trips will continue as at present from the intersection of Topanga Canyon Boulevard and Sherman Way via Sherman Way, Sherman Circle and Van Nuys Boulevard to Ventura Boulevard.

The matter is not controversial and we find the proposed change to be in the public interest. The application will be granted. A public hearing is not necessary.

O R D E R

Application having been made, the Commission being fully advised in the premises, and good cause appearing,

IT IS ORDERED:

(1) That Metropolitan Coach Lines, a corporation, may reroute its Line 90 - Sherman Oaks-Van Nuys-Canoga Park between the intersection of Sherman Circle and Van Nuys Boulevard and the intersection of Sherman Circle and Sherman Way by operating along Van Nuys Boulevard and Sherman Way.

(2) That Appendix A to Decision No. 52821 is hereby amended by incorporating therein First Revised Page 47 of Appendix A attached hereto.

The effective date of this order shall be the date hereof.
