FIFTH INTERIM OPINION AND ORDER

Walkup Drayage and Warehouse Company has been granted authority, under Section 3666 of the Public Utilities Code, to transport property for S & W Fine Foods, Inc., and Equitable Cash Grocery at rates less than the established minimum rates. The authority is scheduled to expire July 31, 1957.

Applicant has filed an amendment to its second supplemental application. The rates sought under the amended application are higher than those presently authorized.

Hearings were held and the matter was taken under submission July 1, 1957, upon the filing of concurrent briefs. The issues are presently being considered by the Commission. It appears, however, that the effective date of a final decision in this matter will be subsequent to the expiration date of the present authority. In order to prevent a lapse of authority pending final determination of this proceeding,

IT IS ORDERED that Walkup Drayage and Warehouse Company, a corporation, is authorized to transport commodities for S & W Fine Foods, Inc., and Equitable Cash Grocery, as described in and subject to the conditions and instructions set forth in Appendix "A",

attached hereto and made a part hereof, between the plants of said companies and points within the City and County of San Francisco at rates less than the minimum rates established for such transportation but not less than the rates shown in said Appendix "A"; and that the authority herein granted shall expire September 30, 1957, unless sooner canceled, changed or extended by order of the Commission.

The effective date of this order shall be July 31, 1957.
