S. Highway 101 between Salinas and the San Francisco Territory, and points on or within 5 miles laterally of the unnumbered County Highway between Salinas and Castroville, on the other hand.

San Francisco Territory means all points and places within the boundaries thereof as shown in Appendix "B" attached hereto and the San Luis Obispo-Santa Maria area means all points and places within the boundaries thereof as shown in Appendix "C" attached hereto.

The authorities hereinabove set forth in paragraphs (b) and (c) do not include the right to render service to, from or between intermediate points.
