OPINION AND ORDER

Applicants are highway common carriers of general commodities. Associated Freight Lines operates generally between the San Francisco Territory and the Los Angeles Territory. Interlines Mctor Express operates generally between San Francisco and Oakland, on the one hand, and Dixon, Davis, Sacramento and points on Highways U.S. 40, U.S. 99, U.S. 99E, U.S. 99W and U.S. 299 between Sacramento and Alturas, including the off-route point of Oroville, on the other hand. By this application authority is sought to establish, on less than statutory notice, through service, through routes and joint rates. The freight would be interchanged at San Francisco or Oakland, Authority is also sought to dopart from the long-and-short-haul provisions of the Constitution and of the Public Utilities Code to the extent necessary to establish the joint rates.

The proposed rates are on the same level as the minimum class rates named in Minimum Rate Tariff No. 2 to and including Class "C" with Class "D" and "E" articles taking Class "C" rates. Service over applicants' lines between the points involved is now subject to combinations of their local rates. These combination rates are higher than the proposed joint rates. Applicants represent that it will be advantageous to the public to be able to make through shipments over their lines under the lower rates. Applicants propose to originate traffic at points served by Associated Freight Lines and

transport it under through routes and joint rates to points served by Interlines Motor Express, and vice versa.

Competing carriers have been notified of the filing of the application. No objection has been received.

It appears that the establishment of the proposed through service, through routes and joint rates, on ten days' notice, is not adverse to the public interest and should be authorized. A public hearing is not necessary.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that applicants be and they are hereby authorized to establish, on not less than ten days' notice to the Commission and the public, through service, through routes and joint rates proposed in the above-entitled application and to depart from the provisions of Article XII, Section 21, of the Constitution of the State of California and Section 460 of the Public Utilities Code to the extent necessary to establish the rates authorized herein.

IT IS HEREBY FURTHER ORDERED that the authority herein granted shall expire unless the authorized rates are made effective within sixty days after the effective date of this order.

This order shall become effective twenty days after the date hereof.
