## SUPPLEMENTAL OPINION AND ORDER

By Decision No. 54564, dated February 25, 1957, the Commission established minimum rates for the transportation of logs in Humboldt and Del Norte Counties. Prior to the effective date of said rates, the Commission in Decision No. 54933, dated May 21, 1957, ordered that the minimum rates so established be suspended until August 20, 1957, so that evidence to be received at further hearings may be considered. The further hearings were held and the matter was taken under submission June 28, 1957. The evidence is being considered by the Commission; it appears, however, that the effective date of a final decision in this proceeding would be subsequent to August 20, 1957. The suspended rates should not become effective pending final decision in this matter. Therefore, good cause appearing,

IT IS ORDERED that Minimum Rate Tariff No. 2 (Appendix "D" of Decision No. 31606, as amended) be and it is hereby further amended by incorporating therein, to become effective August 20, 1957, Supplement No. 39 Cancels Supplement No. 34, attached hereto and by this reference made a part hereof.

In all other respects the aforesaid Decision No. 31606, as amended, shall remain in full force and effect.
