## OPINION

The Greyhound Corporation by this application requests authority to establish two new urban routes within the City of San Diego to be described as follows:

UR-12.10 - From the junction of Broadway and Union Street, over Union Street to C Street to Front Street.

UR-12.11 - From the junction of Ash Street and India Street over Ash Street to Pacific Highway (U. S. Highway 101).

The applicant does not propose by this request to institute any new service or change fares or rates. Moreover this proposal will not affect the frequency of service or the kind or number of units of equipment to be operated.

In justification for the authority requested Greyhound declares that the City of San Diego has adopted a new one-way traffic ordinance over certain city streets and under said ordinance traffic will be restricted to one-way movements only over streets included within Routes UR-12.02 and UR-12.03 as described in Appendix A to Decision No. 47907. At present applicant has been operating in both directions over these streets. It is alleged that the proposed new routes are necessary in order to conform to the requirements of the ordinance.

A public hearing on this matter does not appear to be necessary. No protest to this application has been received. After full

- (2) That Appendix A of Docision No. 47907 is hereby amended by incorporating therein Original Page 78-A.
- (3) That the authority herein granted is an extension and enlargement of, and consolidation with, and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 47907.
- (4) That in providing service pursuant to the certificate herein granted The Greyhound Corporation shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, The Greyhound Corporation shall file a written acceptance of the certificate herein granted.
- (b) Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, The Greyhound Corporation shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and time schedules satisfactory to the Commission.
