Application of TANNER MOTOR TOURS, LTD., for a certificate of public convenience and necessity to operate as a passenger stage corporation, in sightseeing service, from Disneyland territory and Knott's Berry Farm territory with specified tours.

Application No. 39120

OPINION

Applicant now operates an extensive sightseeing passenger stage service throughout Southern California under authority of certificates of public convenience and necessity granted by this Commission. Said operations include many tours on a roundtrip basis, originating at various points in the Los Angeles area, and destined to Disneyland and Knott's Berry Farm, two nationally known tourist and sightseeing points of interest situated in Orange County.

By this application authority is sought to establish and operate a similar touring service, also on a round-trip basis, originating at Disneyland and Knott's Berry Farm.

The following tours and fares are proposed:

Note: Tours Nos. 1004 and 1011 are two-day tours. All tours are subject to a minimum of four fares.

The routes are described in detail, and said tours would originate and terminate within Disneyland and Knott's Berry Farm Territories described as follows:

Disnevland Territory

Beginning at the intersection of Ball Road and Euclid Avenue, thence along Euclid Avenue to the Santa Ana Freeway; southeasterly along the Santa Ana Freeway to Katella Avenue; westerly along Katella Avenue to Harbor Boulevard; southerly along Harbor Boulevard to Orangewood Avenue; westerly along Orangewood Avenue to Euclid Avenue; northerly along Euclid Avenue to point of beginning.

Knott's Berry Farm Territory

Beginning at the intersection of Knotts Avenue and Houston Avenue; thence easterly along Houston Avenue to Dale Avenue; southerly along Dale Avenue to Lincoln Avenue (State Highway No. 18); westerly along Lincoln Avenue to Knotts Avenue; northerly along Knotts Avenue to point of beginning.

Applicant proposes to render the sightseeing service herein described with modern, reclining seat coaches especially designed for sightseeing service. Such equipment would be operated by driver personnel especially trained in sightseeing work. Encoute the drivers lecture on the points of interest along the way. Applicant presently maintains an office at the Disneyland Hotel. This facility would be staffed with personnel trained to acquaint prospective patrons with details of the sightseeing trips herein proposed. Equipment would be based at said territories if required; otherwise, it would be dispatched to meet trip demand from applicant's Los Angeles garage.

As justification for the proposed sightseeing service, applicant alleges that Disneyland is a new point of interest development in the area and has gained nationwide appeal; that Knott's Berry Farm, long a point of sightseeing interest and appeal in the area, has been under a program of continuous development and expansion; that these two developments have caused the establishment of many deluxe hotel-motel accommodations in their areas; that such accommodations have become popular places of stopover for both California and out-of-state tourists; that tourists desire to use such accommodations as a base for visiting Disneyland and Knott's Berry Farm, but they likewise apparently desire to use such

accommodations as a base for visiting other points of interest in Southern California; that the need for the tours herein proposed has come to applicant's attention through operators of Disneyland and Knott's Berry Farm; that applicant proposes to establish the described tours to commence and terminate at popular hours of the day, to the end that the public's sightseeing interest would be adequately met.

The application is not opposed, and the Commission having considered the matter is of the opinion and finds that public convenience and necessity require applicant to establish and operate a sightseeing passenger stage service as hereinafter set forth. The application will be granted. A public hearing is not deemed necessary.

ORDER

Application having been made, the Commission being fully advised in the premises and having found as hereinabove set forth, IT IS ORDERED:

- (1) That a certificate of public convenience and necessity be, and it is hereby granted to Tanner Motor Tours, Ltd., a California corporation, authorizing the establishment and operation of a service as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, for the transportation of persons between the points and places, and along the routes as more specifically described in Appendix A, attached hereto and made a part hereof.
- (2) That in providing service pursuant to the certificate herein granted there shall be compliance with the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 98, may result in a cancellation of the operating authority granted by this decision.
- (b) Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective tariffs and timetables satisfactory to the Commission.

- (a) All persons must be transported on a round-trip or circular tour basis originating in the Disneyland and/or Knott's Berry Farm Territories hereinafter described.
- (b) Applicant shall pick up and discharge passengers only at Disneyland and Knott's Berry Farm, and at the principal hotels and motels situated within the said described Disneyland and Knott's Berry Farm Territories, and in conformance with local traffic rules.
- (c) Subject to the authority of this Commission to change or modify such at any time, Tanner Motor Tours, Ltd., shall conduct said passen- CT STARE OPERATION OVER AND ALONG THE following described routes:

TOUR NO. 1001

Beginning at Disneyland Territory and/or Knott's Berry Farm Territory; thence via State Highway No. 18 or Harbor Boulevard through Fullerton, La Habra and Whittier via Los Angeles Street, Spadra Road and Fullertor Road to Whittier Boulevard; westerly along Whittier Boulevard, Sixth Street and Fifth Street to Los Angeles Territory; along North Broadway, Pasadena Avenue and Figueroa Street to South Pasadena and Pasadena, visiting Old Busch's Gardens, Orange Grove Avenue Residential District, Brookside Park, the Rose Bowl, Pasadena Civic Center, Oak Knoll Residential Section of Pasadena, and the Huntington Library; thence visiting the San Marino Residential District and San Gabriel Mission; thence easterly along Valley Boulevard to Rosemead Boulevard; southerly along Rosemead Boulevard to the Santa Ana Freeway; southeasterly along the Santa Ana Freeway to point of beginning.

TOUR NO. 1006

Beginning at Disneyland Territory and/or Knott's Berry Farm Territory; thence northeasterly via the Santa Ana Freeway, the Pasadena Freeway and San Fernando Road (U. S. Highway No. 99) to Forest Lawn, visiting Forest Lawn points of interest, viz., Little Church of the Flowers, Wee Kirk of the Heather, Mausoleum, Mystery of Life and Masonic Memorial. Returning easterly and southeasterly via Los Feliz Drive, Riverside Drive, the Pasadena and Santa Ana Freeways to point of beginning.
