OPINION

Applicant requests authority to make a minor route change on its East Jefferson-Coliseum Motor Coach Line No. 18 because the City of Los Angeles is establishing one-way traffic on Rodeo Road, eastbound, between Second Avenue and Gramercy Place. The change will necessitate a rerouting of only two blocks on the westbound operation of said line as follows:

Beginning at the intersection of Arlington Avenue and Exposition Boulevard, thence one block to Second Avenue, thence one block to Rodeo Road.

The two-block portion to be abandoned is along Arlington Avenue and Rodeo Road between Exposition Boulevard and Second Avenue.

There will be no material inconvenience to the public and no change in fares or schedules. The Commission finds the proposed change is in the public interest. The application will be granted. A public hearing is not deemed necessary.

ORDER

Application having been made, the Commission being fully advised in the premises, and good cause appearing,

IT IS ORDERED that the route description of applicant's East Jefferson-Coliseum Motor Coach Line No. 18, as now described in Decision No. 51412, be and it hereby is amended to read as set forth in Appendix A attached hereto and made a part hereof.

Commencing at the intersection of 41st Street and Ascot Avenue, thence via 41st Street, Central Avenue, Jefferson Boulevard, Hoover Boulevard, Exposition Boulevard, Second Avenue, Rodeo Road and Coliseum Street to Chesapeake Avenue; and returning via Coliseum Street, Rodeo Road, Exposition Boulevard, Hoover Boulevard, University Avenue, Jefferson Boulevard, Central Avenue and 41st Street to Ascot Avenue.
