Application of METROFOLITAN COACH LINES, a corporation, for authority to reroute its Line 92, Los Angeles-Sierra Vista Local, in the City of Los Angeles.

OPINION

Applicant requests that the route description of its Line 92, Los Angeles-Sierra Vista Local, be amended. The proposed rerouting has become necessary because the City of Los Angeles has realigned Muntington Drive between Mission Road and Locke Avenue in the El Sereno district, with the result that Line 92 will no longer operate over Monterey Road in that vicinity. It appears that this rerouting will not alter any authorizations as to equipment operated, rates, fares, or time schedules which now are in use or effect as to Line 92.

A consideration of this matter leads us to the conclusion and we now find that the proposed rerouting will be in the public convenience and necessity, and accordingly it will be approved. There is no opposition to this proposal. A public hearing is not necessary.

ORDER

Application therefor having been filed and duly considered by the Commission, and it having been found that public convenience and necessity so require, IT IS ORDERED that Metropolitan Coach Lines be and it hereby is authorized to reroute its Line 92, Los Angeles-Sierra Vista Local in accordance with the termini and routes described and specified in Appendix A, which is attached hereto and by this reference made a part hereof. The authority granted herein shall be consolidated with applicant's existing operating authority, and shall be subject to all existing restrictions applicable thereto.

The effective date of this order shall be twenty days after the date hereof.
