SUPPLEMENTAL OPINION AND ORDER

By Decision No. 54564 dated February 25, 1957, in this proceeding, the Commission established minimum rates for the transportation of logs in Humboldt and Del Norte Counties. By Decision No. 54993 as amended by Decision No. 55430, the rates so established were suspended until October 1, 1957.

Further hearings were held and the matter was submitted June 28, 1957. The evidence is being considered. It appears that the effective date of a final decision in this matter can not be prior to October 1, 1957. The rates established in Decision No. 54564 should remain suspended pending final determination herein. Therefore, good cause appearing,

IT IS ORDERED that Minimum Rate Tariff No. 2 (Appendix D of Decision No. 31606, as amended) be and it is hereby further amended by incorporating therein, to become effective September 30, 1957, Supplement No. 40 cancels Supplement No. 39 attached hereto and by this reference made a part hereof.

In all other respects the aforesaid Decision No. 31606, as amended, shall remain in full force and effect.

The effective date of this order shall be September 30, 1957.
